SCENARIO

- Our facility, the Widget Factory USA is about to begin a "Planned Outage."
- During this 10-day (20-Shift) planned outage contractors will perform eight (8) major renovations and facility upgrades. The following renovations and facility upgrades are planned:

SCENARIO

- Facility-wide plumbing renovations with upgrades to:
 - the potable water supply lines,
 - process wastewater, and
 - municipal wastewater systems
- Exterior cleaning, preparation, and painting of the entire facility, including:
 - the main building,
 - wastewater treatment facility,
 - warehouse buildings, and
 - fences

SCENARIO

- Line I Widget Manufacturing System work including:
 - ▶ Demolition,
 - removal, and
 - installation of.
- ► Facility-wide installation of:
 - new fixed industrial stairways,
 - fixed industrial ladders,
 - standard railings, and elevated walking and
 - working surfaces

SCENARIO

- Facility-wide electrical upgrades to:
 - lactrical raceways,
 - ricuit breaker panels, and
 - tie-in of the new Line 1 Widget Manufacturing System
- Cleaning, painting, and striping of the:
 - facility production floor,
 - warehouse floors,
 - laboratory floor, and
 - wastewater plant floor

SCENARIO

- Industrial window services to:
 - inspect all facility windows,
 - clean all acceptable windows, and
 - replace damaged or defective window systems
- ► New Widget Factory USA Integrated Computer System H9000 work including:
 - Installation,
 - implementation,
 - debugging, and
 - operator training in the use of the

EIGHT (8) GROUPS

- ► Eight (8) Management Groups are being assigned one (1) task to perform during the planned outage
 - ▶ Form Eight (8) Management Groups

GROUP ASSIGNMENTS

- ▶ Group I Facility-wide plumbing renovations and upgrades to the potable water supply lines, process wastewater, and municipal wastewater systems
- ► **Group 2** Exterior cleaning, preparation, and painting of the entire facility, including the main building, wastewater treatment facility warehouse buildings, and fences

GROUP ASSIGNMENTS

- ▶ Group 3 Demolition, removal, and installation of a new Line 1 Widget Manufacturing System
- ► **Group 4** Facility-wide installation of new fixed industrial stairways, fixed industrial ladders, standard railings, and elevated walking and working surfaces

GROUP ASSIGNMENTS

- ▶ Group 5 Facility-wide electrical upgrades to electrical raceways, circuit breaker panels, and tie-in of the new Line I Widget Manufacturing System
- ► **Group 6** Cleaning, painting, and striping of the facility production floor, warehouse floors, laboratory floor, and wastewater plant floor

- ► Group 7 Industrial window services to inspect all facility windows, cleaning of acceptable windows, and replacement of damaged or defective window systems
- ▶ Group 8 Installation, implementation, debugging, and operator training in the use of the new Widget Factory USA Integrated Computer System H9000
